TERMS AND CONDITIONS

The following constitute the terms and conditions to which interested individuals agree when registering for any Leading Edge International Aviation Academy Inc. ("LEIAAI") on- line training. Please read the Agreement carefully. You have confirmed your understanding and acceptance of the Agreement by submitting your Pre-Registration.

A. INTRODUCTION TO OUR ON-LINE TRAINING SERVICE

This Agreement governs your registration and attendance to the on-line training.

For successful participation, you will be needing compatible hardware, software and stable Internet access. You are required to use a laptop or desktop with an internal/external webcam and microphone. Mobile devices such as phones or tablets are not allowed. Participants must also have a word processing (such as Microsoft Word), spreadsheet (such as Microsoft Excel) and presentation (such as Microsoft PowerPoint) viewing/editing program. A stable internet connection is required (e.g. Fiber Wi-Fi/Wired connection) and a minimum connection of LTE for mobile broadband users with 8GB data allowance per day for those with data allocation limits (i.e. prepaid and postpaid cellular/mobile data). It is recommended to have at least 3 MBPS bandwidth.

B. DATA PRIVACY

LEIAAI shall collect, process, retain, and store personal data in accordance to the provisions of Republic Act 10173 - Data Privacy Act of 2012. LEIAAI shall be recording the whole duration of the training, including the webcams of participants.

C. SCREENING OF REGISTRATIONS

The compatibility of your device and connection shall be screened in addition to the requirements of the training.

D. NON-APPEARANCE OF APPROVED REGISTRANTS

Approved registrants must be ready to attend the training by 8:00 AM sharp. Logging in late or failure to attend the training all together without prior notice will mean forfeiture of your slot and the consequence of not being accommodated to any LEIAAI training for the next six (6) months.

E. COMPLETION OF TRAINING

Participants must complete the number of hours required in order to obtain their Certificate of Completion. Attendance will be monitored via webcam; therefore, all participants must turn on and share their webcams at all times.

A log-out link shall be provided at the end of each day.

Participants who will miss more than 10% of the allotted time per module shall not be given Certificates of Completion. They must adhere to the Catch-Up Policy of LEIAAI.
